- T: TRADE SUPPLIER** Owner or operator of a business that supplies pool components of the trade. Full Membership Fees
- A: ASSOCIATE MEMBER**
 - (a) LESS than 5 yrs in business, building, planning or supervising the installation of in-ground swimming pools (upgradeable to FULL BUILDER MEMBER after 5 yrs) Full Membership Fees
 - (b) Retail Pool Shop supplying pool associated products to the public. Full Membership Fees
 - (c) Qualified Pool Servicemen. Full Membership Fees
